1. The applicant will pay the Cooperative \$50.00, which, if the Cooperative accepts this application, will constitute the applicant's membership fee. The applicant will be charged a service initiation fee to their first bill.

Standard Billing Deposit Amount \$ _____

A security deposit of \$500.00 or twice the highest bill will be required for consumers with a poor credit rating. A \$300.00 deposit will be required for consumers with a moderate credit rating. The security deposit will be refunded, with interest, after 12 consecutive months of prompt payment. Pay history is periodically evaluated and additional deposits may be required.

Pre-Paid Billing

A minimum balance of \$25 is required to initiate prepay. No additional deposits are required. Electric service is subject to immediate disconnection any time the account does not have a credit balance. Medical conditions or inclement weather will not postpone disconnection.

2. When electric service becomes available, the applicant will purchase from the Cooperative all the electric energy for use on the premises, and will pay monthly at rates set forth by the Cooperative. In the event, the applicant does not utilize the minimum amount of kilowatt-hours set by the board of trustees, the applicant agrees to pay the minimum monthly payment.

3. The applicant will cause its premises to be properly wired in accordance with all applicable electrical codes. The Cooperative may refuse to connect, and may disconnect, power to any service not meeting the codes.

4. Applicant pledges all interest in capital credits accrued or to be accrued in the name of the applicant to the Cooperative as security to insure final payment to the Cooperative.

Access to Premises and Grant of Easement

Applicant understands and agrees, by signing below, the irrevocable, perpetual right and permission to freely enter upon Applicant's real property at such time and with such vehicles or equipment as Cooperative may deem necessary, and a right-of-way easement on, over and upon said property for the purposes of construction, inspection, maintenance and operation of Cooperative's electric or telecommunication system for the benefit of the Applicant and/or other Cooperative members, is hereby granted and conveyed unto the Cooperative, its successors and assigns. Applicant

also agrees to execute a separate easement agreement, if required by Cooperative. Applicant understands and agrees that the Cooperative and contractor personnel and equipment, in the course of operating and maintaining its system, shall have free and unencumbered access to Applicant's property along with the right to clear and control all brush, vines, shrubs, trees and tree limbs situated within the Cooperative power line right-of-way corridor utilizing mechanical methods and herbicide treatments.

IMPORTANT INFORMATION ABOUT HAVING AN ACCOUNT: To help fight identity theft of our members, federal law requires all financial institutions to obtain, verify and record information that identifies each person who opens an account. This means that when you open an account, we will ask for your name, address, date of birth, and other information that will allow us to identify you. We may also ask for some form of identifying identification.

Regulations also require that we obtain permission to contact you via cell phone for outage, billing and collection information, co-op sponsored surveys, or any other call or text to your cellular device that the cooperative deems necessary or important. By signing this document and giving us your cellular number, you are authorizing Central Rural Electric Cooperative to use this cellular device for automated calls and texts to notify you of this information. If, during the time of your service with Central, you no longer have the cellular number(s) given to us, you are responsible for informing the cooperative immediately of the change. At any time, you have the option of opting out of any calls to you.
